

# <u>Accommodation Policy 23/24 Information for students and parents.</u>

The University makes a guarantee of halls accommodation to a number of cohorts of students on an annual basis more explicitly listed below.

#### **Accommodation Guarantees**

Subject to **the Limitations (as set out below)** an offer of single occupancy accommodation in a Hall of Residence will be guaranteed to an applicant who is;

- a) not currently registered as a student at the University but who has been made an **Unconditional** offer to study on a full-time undergraduate or postgraduate programme at the University which the applicant has firmly accepted and who has applied for accommodation by 1<sup>St</sup> August 23:59 of the year of entry onto the programme.
- b) not currently registered as a student at the University but who has been made a **conditional** offer to study on a full time undergraduate or postgraduate programme at the University which the applicant has firmly accepted as a first choice and who has applied for accommodation by 1<sup>St</sup> August of the year of entry onto the programme and has fulfilled the conditions of that offer by 6<sup>th</sup> September 23:59 of the year of entry.

The guarantee extends only to a single occupancy room in halls. There is no guarantee that a particular type of room at a particular rent will be available.

The University reserves the right in its discretion to extend the guarantee to other cohorts of students as deemed appropriate on an annual basis.

### Not covered by the Accommodation Guarantee.

- a) Applicants who put Reading as an insurance choice are <u>NOT</u> guaranteed accommodation in halls. It is important to <u>take note of this</u> as it may mean thatyou need to make alternative private arrangements for accommodation if the halls are oversubscribed.
- b) Returning students there are limited places for returning students in selected room types and for selected contract lengths. No returning student is guaranteed accommodation. Students who have a medical condition or disability which limits their ability to make or find suitable alternative arrangements will be prioritised. Any waiting list will be managed on a first come first serve basis.

## Limitations of offers.

a) Under 18's

No offer of accommodation shall be made to an applicant who is not 17 years of age by the start of the residency period.

b) Students deemed unsuitable for admission into a Hall of Residence.

Examples of students who might be deemed as unsuitable include those with an outstanding debt to the University, those with certain criminal convictions and students with an unsatisfactory disciplinary record. It may also include vexatious complainants or individuals who the University consider in their reasonable opinion to be particularly disruptive.

This is not an exhaustive list and the University reserves the right to withdraw an offer of accommodation at



any time (even after the offer has been made and accepted) should the student be deemed unsuitable in the opinion of the University.

# c) University exchanges and placement programmes

Accommodation may be offered as a part of a University exchange or placement programme (but is not guaranteed).

## Allocations and priority of offers of accommodation

Where possible students will be offered one of their choices of room type preferences; however, there is no guarantee that any of these choices will be available at the time of offer.

Where possible we try and allocate like-minded students together but this is not always possible. Residents may request a room move **after 4 weeks** of taking up occupation. There is no guarantee we can organise a room move but will do as much as is reasonable to assist. If your request is successful, there will be a charge of £50 to cover the associated administrative and cleaning costs.

#### Priority order of allocations/offers

There are numerous factors which influence the priority of offers to rooms. As an example;

- Disabled students who have registered with the University Disability Advisory Service will be prioritised for specific rooms.
- Under 18s will be prioritised for room offers because they do not have opportunities to take out private rental contracts.

After any priority offers are made the University's room allocation system will generate the next offer matched as far as possible to student preferences compared to the available rooms remaining.

NB: rooms are not prioritised for offers on a first come first serve basis due to matching student preferences and other considerations as outlined above.
